Responsibly throughout the supply chain

We engage our partners to our sustainability principles. If we notice any activity in violation of the principles of sustainability, we will start the process of influencing. We give the company the opportunity to correct its process in accordance with the EWQ CSR Code of Conduct.

We foster a high degree of domesticity in our operations and favour domestic partners. If this is not possible, we always carry out a risk assessment and require a sustainability audit of the factory in the country of origin. Domestic design and production ensures a transparent and sustainable supply chain and also creates new jobs in Finland.

Case: SOLUM

The sustainability audit of our supplier SOLUM's factory in Vietnam was a prerequisite for cooperation with us. We started an engaging process in which we gave the company the opportunity to improve its processes in accordance with the EWQ CSR Code of Conduct. In the audit carried out by a third party, particular attention was paid to working conditions and human rights. The process resulted in, for example, reliable monitoring of working hours, a higher minimum wage, the right of employees to form unions and safe day care for children at the factory for the duration of their parents' shifts. The SA8000 certificate granted for the factory ensures a transparent supply chain and ethical trading.
