## WELCOME TO THE DEVELOPING Port of Kaskinen

The Port of Kaskinen is a sheltered deep-sea port serving versatile traffic on the western coast of Finland. It is one of the most important Finnish exporting ports for sawn timber and pulp, and is also specialized in handling chemical industry products and bulk cargo. The port handles over 1 million tons of goods per year.

The most important nearby customers of the Port are the Metsä Board chemi-thermomechanical pulp mill in Kaskinen, Oy Lunawood Ltd and Aureskosken Jalostetehdas Ltd. Efficient and safe handling of material flows is enabled by the modernity and functional infrastructure of the port. Five professional operators provide services for customers within the port area. Large single batches move smoothly between different modes of transportation, storage facilities and vessels. We are able to easily handle more than 15,000 tons of goods each day.

The services and infrastructure of the Port are constantly being developed in order to better serve the diverse customer base. There is an industrial area in the vicinity of the port, which is reserved for future expansions and diversification of supply.

Access routes are also great on land: a well-functioning railyard and direct highway routes provide for smooth land transport connections.*

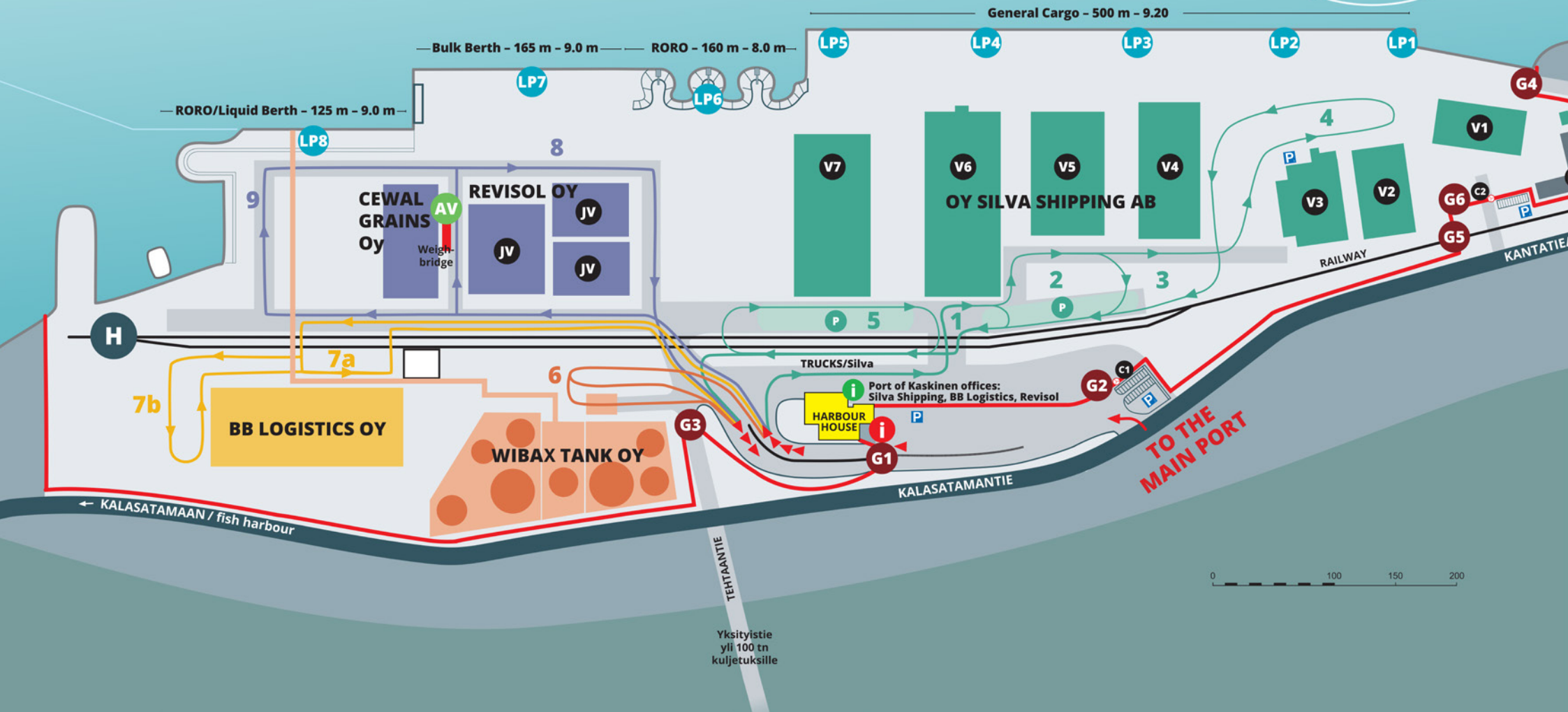

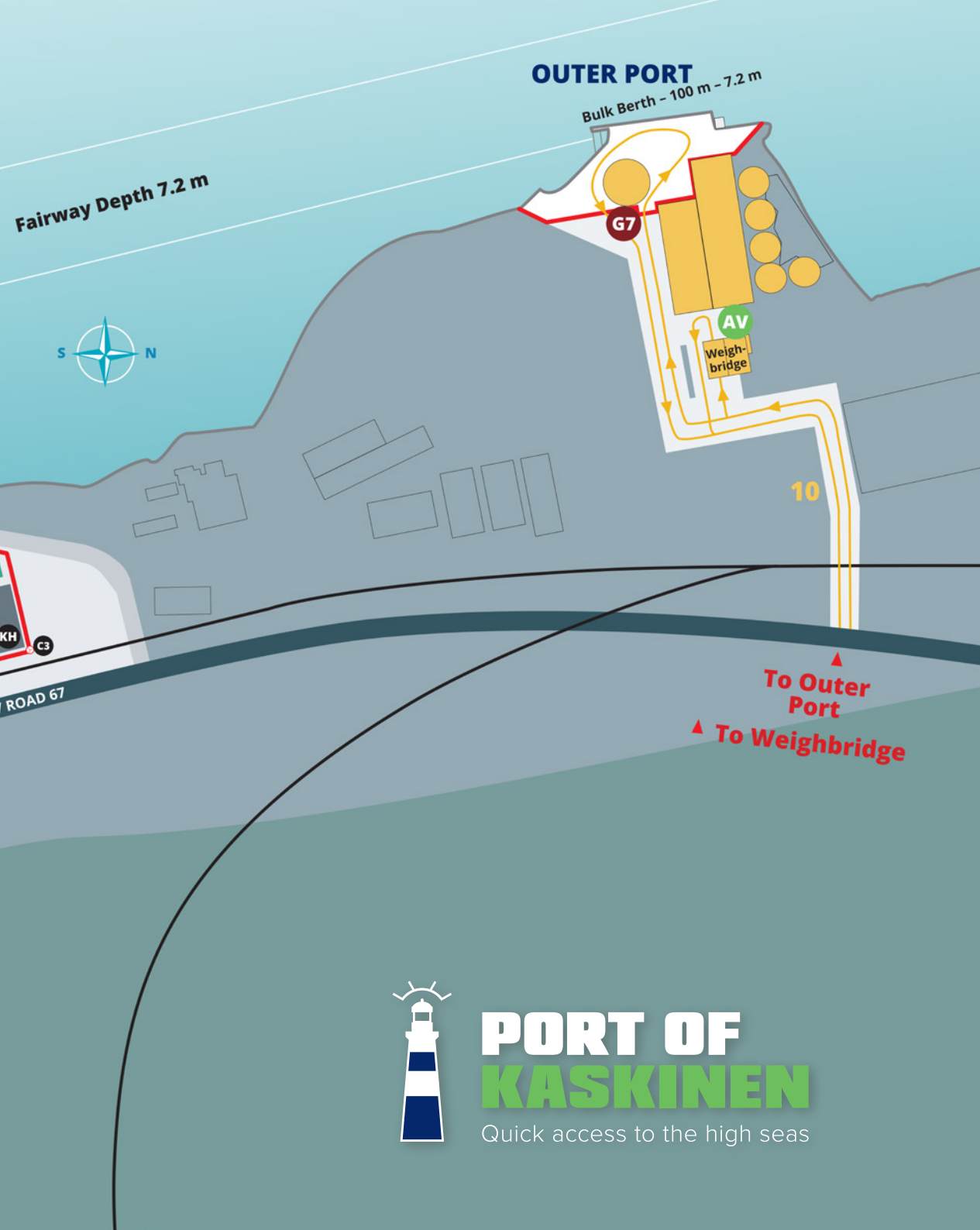

## Key figures:

- Fairway depth: deep-water port of 9 m
- Ship sizes: 1,000–45,000 dwt
- Turning basin: 270 m (inside) 350 m (outside)
- Lolo/Bulk berths: 7 pcs
- RoRo berths: 2 pcs
- Liquid bulk berths: 1 pc
- Storage for general cargo: 38,000 m<sup>2</sup>
- Dry bulk: 15,000 m<sup>2</sup> + 53,500 m<sup>2</sup>
- Liquid bulk: 49,000 m<sup>3</sup>
- Port area: 38 ha

### THE PORT IS DIVIDED INTO ZONES ACCORDING TO THE MATERIAL TO BE HANDLED:

**BB Logistics Oy** – Bulk cargo, loose material (outer harbour and deep harbour)

**Wibax Tank Oy** – Liquid material

**Cewal Grains Oy** – Fertilizers, fodder, grains

**Revisol Oy** – Recyclable materials

**Oy Silva Shipping Ab** – Forest industry

Bulk is handled in both harbours. There are two car scales, one in each harbour.

## CARGO AND RAIL TRANSPORT

The uncongested main road 67 passes by the industrial area directly to the port gate. The Port of Kaskinen is only 14 kilometres away from the crossing of highway E8 and main road 67. Highway E8 is wide enough also for special-sized transports without significant separate operations.

The Port of Kaskinen is also served by a railway. Finland's westernmost train tracks will be utilized more extensively in the future, as the growth and development plans of the Port of Kaskinen also include the revival of rail traffic and the reduction of emissions.

## SERVICE FACILITY

The Port of Kaskinen administers the railway network arriving at the port. The service facility has a 1,200 m long double track with two gears, one at each end, i.e. two 24-car trains can be handled simultaneously. Open, closed and hopper-type wagons can be handled by the current equipment. The maximum axle weight of the rolling stock is 22.5 tons. Storage space is also available in the port.

The service facility is located at Kalasatamantie 30, 64260 Kaskinen. The service facility is maintained by Oy Silva Shipping Ab.

Access to the port area is mainly through the main gate next to the harbour house. The car gate opens with the registration number.

## ACCESS PERMITS

Everybody entering the port area is required to have a permit issued by the port authority. Unauthorized persons may be removed from the area.

The permit is primarily applied for from the operator that is being dealt with in the port. A visit on the ships requires that the ship has arrived at the berth and the visitor is able to name the person to be visited.

## ACCESS CONTROL

The port areas in Kaskinen are monitored by regular patrols and recording CCTV surveillance that covers all berth areas and important functions in the port area.

The port control (tel. +358 40 615 2848) and Securitas (tel. +358 20 491 3029) are responsible for controlling the port area.

## SAFETY WHEN MOVING IN THE AREA

CE-approved reflective clothing must be worn when working in or passing the cargo handling and traffic zones in the port area. When moving in the quay area, you should keep to the middle of the traffic zones and avoid door openings and warehouse corners. The speed limit in the port area is 30 km/h.

The zones between loading and unloading vessels and the warehouses are exclusively reserved for stevedoring activities. Any unnecessary traffic in these areas is forbidden.

## ISPS (International Ship and Port Facility Security Code)

The security procedures of the Port of Kaskinen comply with the international and national regulations on security measures for ships and the port areas serving them. The Finnish Transport and Communications Agency Traficom, the Finnish national supervisory authority, has audited and approved the port security assessments and security plans in 2018.





## WASTE MANAGEMENT

Vessels operating in the port area must collect the different types of waste they produce in the collection facilities assigned to them at the berth.

**NORMAL KITCHEN WASTE** » "EU kitchen waste"

**METAL WASTE** » "metal garbage"

**GLASS WASTE** » "glass garbage"

**OTHER WASTE** » "landfill garbage"

**PROBLEM WASTE** (e.g. accumulators, batteries, waste oils, oily wastes, paints) » contact the ship's agent

**TOILET WASTEWATER** » notification to the port in advance. Based on the notification, a tanker will be ordered to the port.

### VESSELS ARRIVING FROM NON-EU MEMBER STATES:

**All kitchen waste** should be kept completely separate from other waste. A vessel must report its intention to leave waste in the harbour. Based on the report, the harbour will order waste transportation from the waste management company. For waste collection, the vessel receives specially marked yellow waste bags, which must be taken to the yellow collection bins in the harbour marked "non-EU kitchen waste".

- 20 machine units for loading and transferring cargo
